**Welcome**

Dianne Bouvier called the meeting to order at 12:06pm.

**Quorum established (7 of 11 members present).**

**Approve March Minutes**

- Davey made a motion to accept the minutes, Dan seconded, motion passed.

**Guest from EPW (Engineering and Public Works)** - City engineer Jessica Adine invited to review city project updates. Discussion:

1. Palmer street sign – assistant director ordering it, adding blacktop. Shafer street – removed bricks by Cider house, removing more bricks.
2. West union street project – removing more bricks. Requested additional delay at intersection for carpenter and w. union cross walk to add a few extra seconds for pedestrians to cross. An official marked crossing is needed between the apartment house and the front of Family Dollar.
3. Dianne shared tracking sheet link with Jessica and will send her a link. Tracking sheet needs parking on Palmer added to it. Next paving project is kicking off this summer and Jessica will add the parking space to this.
4. Committee discussed how Armitage, Luhrig, 682 needs at least 1 cross walk sign.
5. 682 and Union project proposal-- Design firm submitting proposal and then looking at pedestrian route. Bridge won't be expanded, path towards White's Mill and path on other side.
6. Dianne and Jessica will collaborate to write something from city and adhoc committee highlighting changes and plans resulting from Pedestrian Accessibility Plan
7. Dan stated that Stroud's Run is cluttered on accessible trail (Davey sent email to Friends of Stroud's Run)
8. Discussion of turn lanes and medians to promote pedestrian safety
9. Jessica and Saleh will come to the May meeting with more details on proposed projects.
