**Legislative updates**

● Andrew Chiki,

- Mateo Galvano: No issues are anticipated in Mateo being accepted into AMAC. Appointment is expected at the next City Council meeting.

- Armory: The Armory is close to completion, perhaps by mid-July. The storefront construction is scheduled for completion in early July, so mid-July is cutting it close. There are 7 funding sources for the project. The upper level will be occupied by the anchor tenant, Athens Co Foundation. The main floor will be multi-use / multiple purpose space. The lower level will be shared working spaces managed by Blue Dot. A Space/Facility Manager employment opportunity is open. Andrew is open to offering tours of the Armory afternoons – 12:30 – 2:00.

Discussion/Feedback:

- Stuart – Will rental spaces be retail or office? Office.
- Mateo – Will there be allocated artist studio spaces? Not specifically, but office space could be rented for art studio purposes.

AMAC Admin:

● AMAC Commissioner By-law Change: Kelee Riesbeck

-Commissioner Appointment By-laws: Currently, 4 commissioners must be from within the city limits, and 3 from the township, but all 7 can be from the city. Currently, all 3 township seats are taken, yet others from the township want to serve but are unable. Is the best way forward to open up and expand commissioner residency requirements? Kelee met with the City Law Director and others in order to understand the process and procedure for a city code change. At this point, the feasibility of such a city code change is being looked into.

Discussion/Feedback:

- Mateo suggested flipping the 4/3 city/township mix to 3/4.
- Does RAB have the same board member residency requirements?  
Andrew – There was an alignment across boards and commissions

approximately 3 years ago which may complicate issues. Meaning, if there were a change w/ AMAC, there would need to be changes in the other commissions and boards. The issue is code alignment and possible resultant conflicts.

- Kate: The residency requirement is a problem because we don't have enough people to take on projects such as the Art in City Spaces Project
- Kelee: It doesn't seem as difficult/impossible as before.

- Status of Mateo's candidacy: Kelee Riesbeck

Mateo's candidacy will be reviewed at the City Council Meeting next Monday. No issues are anticipated.

## **Public Projects**

- Sculpture Park

- Opening Ceremony - Tina – The event was wonderful. Four of the sculpture artists were present. Pictures were taken and sent out. About 50 – 60 people attended resulting in an resounding success.

- Available Pad Spaces - Kelee – There are two open sculpture pads available. Perhaps The City could collaborate with OU's sculpture / art people.

- Andrew – There are additional pads open and more can be built later. Regarding OU collaboration, The City will need to establish policies and procedures for removal of artwork, adding more sculptures, sculpture repair, amongst other related considerations such as delineating the responsibilities and duties of parties involved.

- Sculpture Plaques - Kelee – What about them? Andrew – They will happen at some point. Plaques info to include title, description, year, QR codes, other relevant info.

- Athens City Mural Audit and Enhancement

- Mural Walking Tour: Uptown and Around - First walk brochures were printed, second print run TBD. Andrew has 2 full cases left, so please come get them. Mateo wants a bunch to distribute at Bobcats Student Orientation.

- Art Outside the Box Project

- mAppAthens Update – Kate and Tina gave an overview of their project for the benefit of the RAB attendees. The project is not online yet, and updates from Nancy Stevens are hoped for.

- Athens Poet Laureate

- Updates – Tina is sending out advertisements and notices for applicants. Kelee will pass this along to Scott and Ryan. The application is ready to go and to be sent out.

- Art in City Spaces Project

- Updates and Plans for the Future – The lack of a full roster of commissioners is hindering progress. Kelee mentioned she would like to work on the audit, if she has time. Mateo would possibly like to help also.

Next Steps - Look for clarification about what Dairy Barn wants. They would need permission to put their sculpture on city property.

- Hebe the Statue – Andrew – The base is being completed. The statue is currently inside the foyer of City Hall. There will be a period historical background image for the statue. Also, regarding the 150<sup>th</sup> anniversary of City Hall, a short documentary of the history of City Hall was made. Check it out on the city's media channel or You Tube.
