AN ORDINANCE AMENDING THE 2025 APPROPRIATION ORDINANCE 115-24,
AND AUTHORIZING AN INTERFUND TRANSFER.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATHENS, OHIO:

SECTION I: The 2025 Appropriation Ordinance 115-24 is hereby amended by appropriating from the unappropriated balance the sum of Seven Hundred Fifty Thousand Dollars (\$750,000.00) to General Fund, 101, T.C. 600, for transfer, and increasing the total appropriations by said amount.

SECTION II: The Auditor is hereby authorized to make the following interfund transfer:

FROM	TO	AMOUNT
General Fund, 101	Medical Fund, 866	\$750,000.00

SECTION III: The 2025 Appropriation Ordinance 115-24 is further amended by appropriating from the unappropriated balance the sum of Seven Hundred Fifty Thousand Dollars (\$750,000.00) to Medical Fund, 866, T.C. 300, to cover medical expenses, and increasing the total appropriations by said amount.

SECTION IV: This Ordinance shall be in effect and full force upon passage and approval by the Mayor.
