## For AMAC commissioner's review and information

What follows is a recap of AMAC's presentation to the City of Athens Service Safety Committee Oct. 14, 2025 regarding changing Athens City Code 3.07.50. to allow more Athens Countians the opportunity to serve on AMAC. See the document for this effort [here](#).

Recording highlights:

–Sam Crowl, current Council president, suggests we market the open seat to OHIO students, especially art students. Beth Clodfelter spoke in support of that suggestion as well.

–Steve Stone says he's grateful that Council allows him to serve in his role as City Service-Safety Director, even though he is not a City resident. He also says that the Mayor generally likes to seat City residents on city commissions.

–Alan Swank had a few views that appeared to contradict one another. First, he said he was opposed to changing city code in general, and is also concerned about opening seats up to more people who live in Athens Township because they aren't obligated to pay full city taxes. He said he knew 3 people who might be interested in serving and Kelee asked him to provide her with those names. Alan offered to post a promotion to apply to serve on AMAC via 3 neighborhood Facebook pages he belongs to. Second, he asked why residents who live in a section of Canaan Township, home of the Federal Hocking School District, couldn't also be included in the AMAC eligibility map. He said that the WalMart property straddles both Athens and Rome Township and seemed to promote the idea that residents near this area should be eligible to serve as well.
